- 1.2. ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED– (NOT TO BE RE-TYPED) OR ONLINE
- 1.3. DBSA TERMS OF REFERENCE (TOR)

SOURCING OF SERVICE PROVIDER

**TO DELIVER VIRTUAL TRAINING TO DBSA FRONTLINE TEAMS & SUPPORT TEAMS
ON GENDER MAINSTREAMING FOR INFRASTRUCTURE PROJECTS**

1. CONTEXT

The Development Bank of Southern Africa was created to catalyse economic growth through investment in economic and social infrastructure and supporting regional integration. Its strategic objectives are to drive sustainable growth in development impact; integrated infrastructure solutions and financial sustainability. The Bank must unlock infrastructure to the value of R100bn per annum by 2020/2021 as per the Corporate Plan. Against this background, it is imperative to accelerate the development of competencies that will give the institution a competitive advantage both in current and future markets.

2. PURPOSE

The DBSA is seeking to source and appoint a service provider to deliver a customized Infrastructure Projects Gender virtual training programme to the DBSA Investment Officers, Deal Originators, Project/Programme Managers, Specialists and Heads (Frontline and Support teams).

3. THE SCOPE OF THE PROGRAMME

The appointed Service Provider is expected to design and customise a targeted learning programme on mainstreaming gender issues into Infrastructure Projects for the frontline and support teams. This Gender Mainstreaming project is meant to suit the DBSA's specific needs and scope as follows:

- a. Understanding of what Gender Mainstreaming is;
- b. Sharing elements of the DBSA's Gender Mainstreaming Strategy or position;
- c. A list of critical or relevant gender legislative requirements and protocols, such as Sustainable Development Goals (SDGs), SADC Protocols on Gender, Green Climate Fund (GCF) requirements, and Global Environmental Facility (GEF)'s gender requirements;
- d. Impact of Gender Mainstreaming on infrastructure financing of major projects in Africa (examples of success stories to be used by the successful service provider);
- e. Gender Mainstreaming considerations on infrastructure projects at all stages of the investment value chain from project conceptualization, project preparation, through early review and due diligence, and all the way to monitoring and evaluation;
- f. How to conduct Gender Analysis, Gender Assessments and Gender Action Plans;
- g. Possible Gender Mainstreaming tools (i.e. Gender Marker System);
- h. ROI for Mainstreaming Gender; and
- i. How to measure Gender Mainstreaming on an organization's business scorecard (BSC KPIs).

4. OUT OF SCOPE

Internal Gender Mainstreaming issues like recruitment, succession management, retention etc.

- Customisation will enable further alignment with the DBSA business' current operating model, culture, strategy, DBSA, Values and Behaviours.
- The method of delivery should be experiential learning (through virtual training sessions, case study driven, simulations, relevant articles and reading relevant material).
- The duration of the programme should be informed by the content but not exceed eight (8 weeks).

5. REQUIRED EXPERTISE OR GOODS/ PRODUCTS

The Service Provider and/or Facilitator for the Gender Mainstreaming for Infrastructure Projects Course is expected to have/do the following:

- The institution/service provider should have over 10 years of practical experience in designing, developing, implementing and training for (Frontline & support) teams on Gender Mainstreaming;
- It will be advantageous to work with an institution that has a **niche** in **Gender Mainstreaming** or other similar products;
- Facilitators should have 10 years of facilitation skills and demonstrable experience in facilitating adult education and training on Gender Mainstreaming in projects (preferably infrastructure projects); and
- Written references (on a letterhead) from a minimum of five (5) leading organizations. At least one (1) of the references from financial services or related sectors will be an advantage.

6. NUMBER OF PARTICIPANTS

The DBSA will nominate +- 150 employees which includes (Investment Officers, Deal Originators, Project/Programme Managers, Specialists, Heads & support teams) from across the business to attend this important training session.

7. TIME FRAMES, DURATION AND TRAINING PLATFORM

Upon successful appointment, the Service Provider shall be expected to immediately commence work. 5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
