- 1.3 **B-BBEE status level of contributor** means the B-BBEE status received by a measured entity based on its overall performance used to claim points in terms of regulation 6 and 7 of the Preferential Procurement Regulations, 2017.
- 1.4 **Business Day** means a day which is not a Saturday, Sunday or public holiday.
- 1.5 **Bid** means a written offer in the prescribed or stipulated form lodged by a Bidder in response to an invitation in this Request for Proposal, containing an offer to provide goods, works or services in accordance with the Specification as provided in this RFP.
- 1.6 **Bidder** means a person or legal entity, or an unincorporated group of persons or legal entities that submit a Bid.
- 1.7 **Companies Act** means the Companies Act, 2008.
- 1.8 **Compulsory Documents** means the list of compulsory schedules and documents set out in Part B.
- 1.9 **Closing Time** means the time, specified as such under the clause 4 (Bid Timetable) in Part C, by which Tenders must be received.
- 1.10 **DBSA** means the Development Bank of Southern Africa Limited.
- 1.11 **DFI** means Development Finance Institution.

8. ACCURACY OF REQUEST FOR PROPOSAL

- 8.1 Whilst all due care has been taken in connection with the preparation of this RFP, the DBSA makes no representations or warranties that the content in this RFP or any information communicated to or provided to Bidders during the Tendering Process is, or will be, accurate, current or complete. The DBSA, and its officers, employees and advisors will not be liable with respect to any information communicated which is not accurate, current or complete.
- 8.2 If a Bidder finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this RFP or any other information provided by the DBSA (other than minor clerical matters), the Bidder must promptly notify the DBSA in writing of such discrepancy, ambiguity, error or inconsistency in order to afford the DBSA an opportunity to consider what corrective action is necessary (if any).
- 8.3 Any actual discrepancy, ambiguity, error or inconsistency in this RFP or any other information provided by the DBSA will, if possible, be corrected and provided to all Bidders without attribution to the Bidder who provided the written notice.

- 14.3 Bidders are to be familiar with the implications of contravening the Prevention and Combating of Corrupt Activities Act, 2004 and any other relevant legislation.

15. ANTI-COMPETITIVE CONDUCT

- 15.1 Bidders and their respective officers, employees, agents and advisors must not engage in any collusion, anti-competitive conduct or any other similar conduct in respect of this Tendering Process with any other Bidder or any other person(s) in relation to:
 - 15.1.1** the preparation or lodgement of their Bid
 - 15.1.2** the evaluation and clarification of their Bid; and
 - 15.1.3** the conduct of negotiations with the DBSA.
- 15.2 For the purposes of this clause 15, collusion, anti-competitive conduct or any other similar conduct may include disclosure, exchange and clarification of information whether or not such information is confidential to the DBSA or any other Bidder or any other person or organisation.
- 15.3 In addition to any other remedies available to it under law or contract, the DBSA may, in its absolute discretion, immediately disqualify a Bidder that it believes has engaged in any collusive, anti-competitive conduct or any other similar conduct during or before the Tendering Process.

16. COMPLAINTS ABOUT THE TENDERING PROCESS

- 16.1 Any complaint about the RFP or the Tendering Process must be escalated to the Supply Chain Management Unit in writing, by email, immediately upon the cause of the complaint arising or becoming known to the Bidder, (scmqueries@dbsa.org)
- 16.2 The written complaint must set out:
 - 16.2.1** the basis for the complaint, specifying the issues involved;
 - 16.2.2** how the subject of the complaint affects the organisation or person making the complaint;
 - 16.2.3** any relevant background information; and
 - 16.2.4** the outcome desired by the person or organisation making the complaint.

16.3 If the matter relates to the conduct of an employee of the DBSA, the complaint should be addressed in writing marked for the attention of the Chief Executive Officer of the DBSA, and delivered to the physical address of the DBSA, as notified.

17. CONFLICT OF INTEREST

17.1 A Bidder must not, and must ensure that its officers, employees, agents and advisors do not place themselves in a position that may give rise to actual, potential or perceived conflict of interest between the interests of the DBSA and the Bidder's interests during the Tender Process.

17.2 The Bidder is required to provide details of any interests, relationships or clients which may or do give rise to a conflict of interest in relation to the supply of the services under any contract that may result from this RFP. If the Bidder submits its Bid and a subsequent conflict of interest arises, or is likely to arise, which was not disclosed in the Bid, the Bidder must notify the DBSA immediately in writing of that conflict.

17.3 The DBSA may immediately disqualify a Bidder from the Tendering Process if the Bidder fails to notify the DBSA of the conflict as required.

18. LATE BIDS

18.1 Bids must be delivered by the Closing Time. The Closing Time may be extended by the DBSA in its absolute discretion by providing written notice to Bidders.

18.2 Bids delivered after the Closing Time or lodged at a location or in a manner that is contrary to that specified in this RFP will be disqualified from the Tendering Process and will be ineligible for consideration. However, a late Bid may be accepted where the Bidder can clearly demonstrate (to the satisfaction of the DBSA, in its sole discretion) that late lodgement of the Bid was caused by the DBSA; that access was denied or hindered in relation to the physical tender box; or that a major/critical incident hindered the delivery of the Bid and, in all cases, that the integrity of the Tendering Process will not be compromised by accepting a Bid after the Closing Time.

18.3 The determination of the DBSA as to the actual time that a Bid is lodged is final. Subject to clause 18.2, all Bids lodged after the Closing Time will be recorded by the DBSA and will only be opened for the purposes of identifying a business name and address of the Bidder. The DBSA will inform a Bidder whose Bid was lodged after the Closing Time of its ineligibility for consideration. The general operating practice is for the late Bid to be returned within 5 (five) working days of receipt or within 5 (five) working days after determination not to accept a late Bid.

19. BIDDER'S RESPONSIBILITIES

19.1 Bidders are responsible for:

- 19.1.1 examining this RFP and any documents referenced or attached to this RFP and any other information made or to be made available by the DBSA to Bidders in connection with this RFP;
- 19.1.2 fully informing themselves in relation to all matters arising from this RFP, including all matters regarding the DBSA's requirements for the provision of the Services;
- 19.1.3 ensuring that their Bids are accurate and complete;
- 19.1.4 making their own enquiries and assessing all risks regarding this RFP, and fully considering and incorporating the impact of any known and unknown risks into their Bid;
- 19.1.5 ensuring that they comply with all applicable laws in regards to the Tendering Process particularly as specified by National Treasury Regulations, Guidelines, Instruction Notes and Practice Notes and other relevant legislation as published from time to time in the Government Gazette; and
- 19.1.6 submitting all Compulsory Documents.

19.2 Bidders with annual total revenue of R10 million or less qualify as Exempted Micro Enterprises (EMEs) in terms of the B-BBEE Act must submit a certificate issued by a registered, independent auditor (who or which is not the Bidder or a part of the Bidder) or an accredited verification agency.

19.3 **All Bidders must submit their original and valid B-BBEE status level verification certificate or original certified copy, or original sworn affidavit thereof, substantiating their B-BBEE status. The submission of such certificates must comply with the requirements of instructions and guidelines issued by National Treasury and be in accordance with the applicable notices published by the Department of Trade and Industry in the Government Gazette.**

19.4 The DBSA reserves the right to require of a Bidder, either before a Bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the DBSA.

19.5 Failure to provide the required information may result in disqualification of the Bidder.

20. PREPARATION OF BIDS

20.1 Bidders must ensure that:

- 20.1.1 their Bid is submitted in the required format as stipulated in this RFP; and
- 20.1.2 all the required information fields in the Bid are completed in full and contain the information requested by the DBSA.

- 20.2 The DBSA may in its absolute discretion reject a Bid that does not include the information requested or is not in the format required.
- 20.3 Unnecessarily elaborate responses or other representations beyond that which is sufficient to present a complete and effective tender proposal are not desired or required. Elaborate and expensive visual and other presentation aids are not necessary.
- 20.4 Where the Bidder is unwilling to accept a specified condition, the non-acceptance must be clearly and expressly stated. Prominence must be given to the statement detailing the non-acceptance. It is not sufficient that the statement appears only as part of an attachment to the Bid, or be included in a general statement of the Bidders usual operating conditions.
- 20.5 An incomplete Bid may be disqualified or assessed solely on the information completed or received with the Bid.

21. ILLEGIBLE CONTENT, ALTERATION AND ERASURES

- 21.1 Incomplete Bids may be disqualified or evaluated solely on information contained in the Bid.
- 21.2 The DBSA may disregard any content in a Tender that is illegible and will be under no obligation whatsoever to seek clarification from the Bidder.
- 21.3 The DBSA may permit a Bidder to correct an unintentional error in its Bid where that error becomes known or apparent after the Closing Time, but in no event will any correction be permitted if the DBSA reasonably considers that the correction would materially alter the substance of the Bid or effect the fairness of the Tendering Process.

22. OBLIGATION TO NOTIFY ERRORS

If, after a Bidder's Response has been submitted, the Bidder becomes aware of an error in the Bidders Response (including an error in pricing but excluding clerical errors which would have no bearing on the evaluation of the Bid), the Bidder must promptly notify the DBSA of such error.

23. RESPONSIBILITY FOR BIDDING COSTS

- 23.1 The Bidders participation or involvement in any stage of the Tendering Process is at the Bidders sole risk, cost and expense. The DBSA will not be held responsible for, or pay for, any expense or loss that may be incurred by Bidders in relation to the preparation or lodgement of their Bid.

23.2 The DBSA is not liable to the Bidder for any costs on the basis of any contractual, promissory or restitutionary grounds whatsoever as a consequence of any matter relating to the Bidders participation in the Tendering Process, including without limitation, instances where:

23.2.1 the Bidder is not engaged to perform under any contract; or

23.2.2 the DBSA exercises any right under this RFP or at law.

24. DISCLOSURE OF BID CONTENTS AND BID INFORMATION

24.1 All Bids received by the DBSA will be treated as confidential. The DBSA will not disclose contents of any Bid and Bid information, except:

24.1.1 as required by law;

24.1.2 for the purpose of investigations by other government authorities having relevant jurisdiction;

24.1.3 to external consultants and advisors of the DBSA engaged to assist with the Tendering Process; or for the general information of Bidders required to be disclosed as per National Treasury Regulations, Guidelines, Instruction Notes or Practice Notes.

25. USE OF BIDS

25.1 Upon submission in accordance with the requirements relating to the submission of Bids, all Bids submitted become the property of the DBSA. Bidders will retain all ownership rights in any intellectual property contained in the Bids.

25.2 Each Bidder, by submission of their Bid, is deemed to have licensed the DBSA to reproduce the whole, or any portion, of their Bid for the sole purposes of enabling the DBSA to evaluate the Bid.

26. BID ACCEPTANCE

All Bids received must remain open for acceptance for a minimum period of 90 (Ninety) days from the Closing Time. This period may be extended by written mutual agreement between the DBSA and the Bidder.

27. EVALUATION PROCESS

27.1 The Bids will be evaluated and adjudicated as follows:

27.1.1 Qualification – evaluation of compliance with Pre-Qualifying Criteria

Only those Bidders which satisfy all of the Pre-Qualifying Criteria will be eligible to participate in the Tendering Process further. Bids which do not satisfy all of the Pre-Qualifying Criteria will not be evaluated further.

27.1.2 First stage – functional evaluation

Bidders are evaluated based on the functional criteria set out in this RFP. Only those Bidders which score [70] points or higher (out of a possible 100) during the functional evaluation will be evaluated during the second stage (demonstration) of the Bid. The functional evaluation will include demonstrations by the Bidders.

27.1.3 Second stage – price and preferential points

27.1.3.1 Those Bidders which have passed the qualification and first stages including demonstrations of the tender process will be scored on the basis of price and preference point allocation in accordance with the applicable legislation.

27.1.3.2 The successful Bidder will be the Bidder that scores the highest number of points in the second stage of the Bid evaluation, unless the DBSA exercises its right to cancel the RFP, in line with the PPPFA Regulations.

27.2 NB: Bidders are required to submit, as Annexure J to their Bids, any documentation which supports the responses provided in respect of the Pre-Qualifying Criteria and Functional Criteria below.

27.3 Qualification: Pre-Qualifying Criteria

27.3.1 The following Pre-Qualifying Criteria will be applied in the initial stage of the evaluation. Bidders who do not meet all of the Pre-Qualifying Criteria will not be considered for award of the tender.

27.3.2 Bidders are required to complete the table below by indicating whether they comply with the requirement by marking the appropriate column with an 'X' below. Bidders are required to submit supporting documentation evidencing their compliance with each requirement, where applicable.

Note: A tender that fails to meet any Pre-Qualifying Criteria stipulated herein in the tender documents is an unacceptable tender.

27.4 **First Stage: Functional Criteria**

27.4.1 Only those Bidders which score [70] points or higher (out of a possible 100) during the functional evaluation will be evaluated during the second stage of the Bid. Bidders are required to submit supporting documentation evidencing their compliance with each requirement, where applicable.

27.4.2 The Functional Criteria that will be used to test the capability of Bidders are tabled below.

27.4.3 A minimum of [70] points out of a 100 for the functional/ evaluation will qualify the Bid to move on to the next stage of evaluation.

27.5 **Second Stage: Price and Preferential Points Assessment**

27.5.1 Subsequent to the evaluation of Pre-qualifying Criteria and Functional Criteria, the second stage of evaluation of the Bids will be in respect of price and preferential procurement only. Points will be allocated to Bidders at this stage of the evaluation in accordance with the PPPFA and the PPPFA Regulations, as follows:

Price points 80; Preferential procurement points 20

27.5.2 Price points

The following formula will be used to calculate the points for price:

$$P_s = 80(1 - (P_t - P_{min}) / P_{min})$$

Where:

P_s = Points scored for comparative price of tender or offer under consideration;

P_t = Comparative price of tender or offer under consideration; and

P_{min} = Comparative price of lowest acceptable tender or offer.

27.5.3 Preferential procurement points

A maximum of 20 points may be awarded in respect of preferential procurement, which points must be awarded to a tenderer for attaining their B-BBEE Status Level in accordance with the table below:

An unincorporated trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate Bid.

27.5.4 Total

The total points scored by each Bidder will be calculated by adding the points scored for price (out of 80) to the points scored for preferential procurement (out of 20).

28. STATUS OF BID

28.1 Each Bid constitutes an irrevocable offer by the Bidder to the DBSA to provide the Services required and otherwise to satisfy the requirements of the Specification as set out in this RFP.

28.2 A Bid must not be conditional on:

- 28.2.1** the Board approval of the Bidder or any related governing body of the Bidder being obtained;
- 28.2.2** the Bidder conducting due diligence or any other form of enquiry or investigation;
- 28.2.3** the Bidder (or any other party) obtaining any regulatory approval or consent;
- 28.2.4** the Bidder obtaining the consent or approval of any third party; or
- 28.2.5** the Bidder stating that it wishes to discuss or negotiate any commercial terms of the contract.

28.3 The DBSA may, in its absolute discretion, disregard any Bid that is, or is stated to be, subject to any one or more of the conditions detailed above (or any other relevant conditions).

28.4 The DBSA reserves the right to accept a Bid in part or in whole or to negotiate with a Bidder in accordance with the provisions of this RFP and the applicable laws and regulations.

29. CLARIFICATION OF BIDS

29.1 The DBSA may seek clarification from and enter into discussions with any or all of the Bidders in relation to their Bid. The DBSA may use the information obtained when clarification is sought or discussions are had in interpreting the Bid and evaluating the cost and risk of accepting the Bid. Failure to supply clarification to the satisfaction of the DBSA may render the Bid liable to disqualification.

29.2 The DBSA is under no obligation to seek clarification of anything in a Bid and reserves the right to disregard any clarification that the DBSA considers to be unsolicited or otherwise impermissible or irrelevant in accordance with the rules set out in this RFP.

30. DISCUSSION WITH BIDDERS

30.1 The DBSA may elect to engage in detailed discussions with any one or more Bidder(s), with a view to maximising the benefits of this RFP as measured against the evaluation criteria and in fully understanding a Bidder's offer.

30.2 As part of the evaluation of this Bid, DBSA will invite Bidders to give a presentation to the DBSA in relation to their submissions.

30.3 The DBSA is under no obligation to undertake discussions with, and Bidders.

30.4 In addition to presentations and discussions, the DBSA may request some or all Bidders to:

30.4.1 conduct a site visit, if applicable;

30.4.2 provide references or additional information; and/or

30.4.3 make themselves available for panel interviews.

31. SUCCESSFUL BIDS

31.1 Selection as a successful Bidder does not give rise to a contract (express or implied) between the successful Bidder and the DBSA for the supply of the Services. No legal relationship will exist between the DBSA and a successful Bidder for the supply of the Services until such time as a binding contract is executed by them.

31.2 The DBSA may, in its absolute discretion, decide not to enter into pre-contractual negotiations with a successful Bidder.

31.3 A Bidder is bound by its Bid and all other documents forming part of the Bidder's Response and, if selected as a successful Bidder, must enter into a contract on the basis of the Bid with or without further negotiation.

32. NO OBLIGATION TO ENTER INTO CONTRACT

32.1 The DBSA is under no obligation to appoint a successful Bidder or Bidders (as the case may be), or to enter into a contract with a successful Bidder or any other person, if it is unable to identify a Bid that complies in all relevant respects with the requirements of the DBSA, or if due to changed circumstances, there is no longer a need for the Services requested, or if funds are no longer available to cover the total envisaged expenditure. For the avoidance of any doubt, in these circumstances the DBSA will be free to proceed via any alternative process.

32.2 The DBSA may conduct a debriefing session for all Bidders (successful and unsuccessful). Attendance at such debriefing session is optional.

33. BIDDER WARRANTIES

33.1 By submitting a Bid, a Bidder warrants that:

33.1.1 it did not rely on any express or implied statement, warranty or representation, whether oral, written, or otherwise made by or on behalf of the DBSA, its officers, employees, or advisers other than any statement, warranty or representation expressly contained in the RFP;

33.1.2 it did not use the improper assistance of DBSA's employees or information unlawfully obtained from them in compiling its Bid;

33.1.3 it is responsible for all costs and expenses related to the preparation and lodgement of its Bid, any subsequent negotiation, and any future process connected with or relating to the Tendering Process;

33.1.4 it accepts and will comply with the terms set out in this RFP; and

33.1.5 it will provide additional information in a timely manner as requested by the DBSA to clarify any matters contained in the Bid.

34. DBSA'S RIGHTS

- 34.1 Notwithstanding anything else in this RFP, and without limiting its rights at law or otherwise, the DBSA reserves the right, in its absolute discretion at any time, to:
- 34.1.1 cease to proceed with, or suspend the Tendering Process prior to the execution of a formal written contract;
 - 34.1.2 alter the structure and/or the timing of this RFP or the Tendering Process;
 - 34.1.3 vary or extend any time or date specified in this RFP
 - 34.1.4 terminate the participation of any Bidder or any other person in the Tendering Process;
 - 34.1.5 require additional information or clarification from any Bidder or any other person;
 - 34.1.6 provide additional information or clarification;
 - 34.1.7 negotiate with any one or more Bidder;
 - 34.1.8 call for new Bid;
 - 34.1.9 reject any Bid received after the Closing Time; or
 - 34.1.10 reject any Bid that does not comply with the requirements of this RFP.

35. GOVERNING LAWS

- 35.1 This RFP and the Tendering Process are governed by the laws of the Republic of South Africa.
- 35.2 Each Bidder must comply with all relevant laws in preparing and lodging its Bid and in taking part in the Tendering Process.
- 35.3 All Bids must be completed using the English language and all costing must be in South African Rand.

36. MANDATORY QUESTIONS

- 36.1 Bidders shall provide full and accurate answers to all (including mandatory) questions posed in this document, and, are required to explicitly state "Comply/Accept" or "Do not comply/Do not accept" (with a ✓ or an X) regarding compliance with the requirements. Where necessary, the Bidders shall substantiate their response to a specific question.

NOTE: It is mandatory for Bidders to complete or answer this part fully; failure to do so result the Bid being treated as incomplete and the Bid may be disqualified.

Terms of Reference

1. INTRODUCTION

The Development Bank of Southern Africa (DBSA) is a development finance institution (DFI) that promotes economic and social development by mobilising financial and other resources from the national and international private and public sectors for sustainable development projects in South Africa and the rest of the African continent. The DBSA's mandate is to provide financial, technical and other assistance, with a focus on infrastructure investment.

As a State-Owned Entity (SoE), the DBSA is aligned to the country's, regional, and international policy imperatives. The country policies include the National Development Plan (NDP), the Integrated Urban Development Framework (IUDF), the National Climate Change Response Policy (NCCRP). Within the region the DBSA is aligned to Regional Infrastructure Master Plans and Africa Union's Agenda 2063. Internationally, the DBSA is aligned to the Sustainable Development Goals (SDGs) (United Nations 2012), the Paris Agreement (United Nations 2015), and the New Urban Agenda (NUA) (United Nations 2016), all with the purpose of accelerating economic growth and development, as well as eliminating poverty and reducing inequality. In the context of the above, the Bank focuses on Water, Transport, Energy and ICT sectors to promote economic infrastructure and focuses on the Education, Health and Housing sectors to deepen social infrastructure.

2. BACKGROUND

Worldwide DFIs adopt different approaches to measuring the development results of projects. The various DFIs adopt strategies that align with national government priorities and measure development results using a combination of the following:

- Focusing on National Priorities, where the project is usually large and addresses national infrastructure problem;
- Strategic fit, such as aligning with national priorities;
- Deliverability: where the project is measured on its feasibility and sustainability;
- Providing economic benefit, particularly where private sector is not dominant; and
- The project is able to address key risks.

The need for DFIs to report on the development results of their investments cannot be underestimated. Development results are concerned with development changes that occur as a result of project implementation which leads to improvements in people's lives. Although the DFI's outputs and activities are important, they are in support of the national agenda and thus

aligns with the national planning and therefore remain centered on supporting the national imperatives.

The South African National Development Plan (NDP) aligns itself to SDGs and the New Urban Agenda (NUA) which clearly communicate economic, social, financial, environmental and infrastructure needs. In its review of the role of all South African DFIs, the NDP recognised “that greater clarity be provided on the respective niche areas filled by each DFI and that coordination be improved to maximise their developmental impact”.

In response to the latter and in alignment with the country’s policy imperatives, the DBSA has developed a set of initiatives to improve the collection of data and information to enhance reporting on its development results. The Bank reports on the development results and effectiveness of its interventions and also submit our development results, case studies, recommendations and lessons learnt from its funding activities to both its internal and external stakeholders, particularly the National Treasury, the DBSA’s shareholder. The recommendations, lessons learnt and case studies arising from the evaluation of its activities comprise a key aspect of the DBSA’s knowledge management, sharing and capacity development strategy.

In 2014, the DBSA identified the need to accurately report on its development results and the Development Results Template (DRT) was developed as a tool to assist the Bank in collecting data and information on anticipated development results at project level. Formalization and improvement of the DRT tool occurred in 2015 upon which the Bank realised the need for a formalized DR Framework resulting in the development of the Bank’s Development Result Reporting Framework (DRRF).

The DRRF and the Monitoring and Evaluation (M&E) Policy were approved and adopted during the course of 2017. The DRRF provides a framework for the Bank to report on its development results and integrates the M&E processes into the Bank’s existing systems and processes. The aim of the DRRF is to enhance accountability and performance of the Bank’s operations as well as facilitate accurate development results reporting of the Bank’s interventions. The DRRF outlines the manner in which the Bank’s development results and outcomes are measured and details the tools, indicators and measures that are employed.

The key measurement tools that are utilized to monitor and measure development results and outcomes are the Core Sector Indicator Framework (CSIF) and the Development Results

Template (DRT) and its associated monitoring template and Project Completion Report (PCR). The CSIF provides a list of project specific indicators, a selection of which are included in the project specific DRT as per each project's requirements. The DRT provides an overview of project details, associated anticipated outputs and outcomes which are identified through the project specific indicators selected from the CSIF. For measuring the "Actual Results" the DRRF uses the Monitoring Report (MR) to track outputs and outcomes specified in the DRT.

In addition, the actual results are tracked using the Project Completion Report (PCR) that provides the project specific outputs and outcomes achieved at project completion stage. Lastly, to measure the "Verified Results" the DRRF uses evaluations and output assessments to verify development results tracked through MR and PCR.

At the end of 2019, the DBSA undertook a balance scorecard review process and the key recommendation of the review was to enhance the Bank's corporate scorecard by increasing the focus on the Bank's developmental mandate. The key measure that is being proposed to drive the developmental focus within the organisation is the Development Impact Index (DII).

The aim of the DII is to enable the Bank to more effectively measure the development impact of its investments. The DBSA has identified the need to rank its various projects/programmes in terms of the project or programmes proposed development results and impact. The formulation of such a ranking is complex and multidimensional as a result of the context within which the Bank operates and the variety and the type of projects that the Bank finances as well as the variety in their development results.

The existing DRRF and the DRT will be used as the basis for the development of the DRT and the DII will form part of the suite of tools that comprise the DRRF. The DRRF and the M&E policy are currently under review and the development of the DII will align with and form part of the broader DRRF revision.

3. OBJECTIVES

The DBSA is seeking to appoint a Professional Service Provider (PSP) to develop development impact index based on the Bank's existing systems and processes.

The objectives of the assignment are:

- To develop the Development Impact Index (DII) that is aligned to the existing Development Results Reporting Framework (DRRF);
- To review and refine existing development indicators currently in use and define any additional indicators that will be utilized as part of the Development Impact Index (DII);
- To pilot the tool with actual projects;
- To provide skill transfer to DBSA staff to ensure continued employment of the tool within the organisation.

4. SCOPE OF WORK

•4.1 SCOPE

The ability of the DBSA to report on development results of its investments is dependent on the tools it has put in place to measure development results. Such tool includes DRT, CSIF, MR and PCR which are all components of the DRRF. The DII will be based on the data and information gathered as part of the existing development results reporting process. The scope for this assignment is as follows:

- Review of the current suite of tools including:
 - Review DRRF and propose changes that may be required to support the DII;
 - Review the Development Result Template and associated templates that are currently in use as part of the DRRF;
 - Engagements with the OEU team to understand the processes and logic behind the development of the current DRT; and
 - Align the revised DRT to the current DRRF review.
- Develop Development Impact Index

- Develop DII that clearly indicates a summary of measures of average “Anticipated Development Result” based on the three components of the DRT;
- Development of the DII should consider the following key aspects
 - Typology of DBSA projects and dynamics within projects
 - Types of DBSA investments
 - Data availability to complete DRTs
 - The development context of the country and the region.
- Align the DII with the DRRF;
- Develop DII guideline and user manual that will align with the DRT; and
- Engage with the DBSA OEU team through the development of the DII and develop a clear documentation of engagements that are to be submitted as part of the project close out report.
- Pilot the DII tool
 - Pilot/implement the adopted DII tool with projects that have reached commitment stage (both SA and international projects); and
 - Adjust the DII based on results of the pilot.
- Provide skills transfer to DBSA staff, particularly OEU team.

Key considerations

- The DII is to be developed to fully integrate into the existing DRRF of the DBSA;
- The DII should integrate into to the DRT and should not require the collection or capture of additional information or data not already captured by the DBSA’s DRT and monitoring processes;
- The DII should not require a separate system, and process of templates; and
- The DII to be developed within four months of the signing of the contract.
