- 1.2. **ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED – (NOT TO BE RE-TYPED) OR IN THE MANNER PRESCRIBED IN THE BID DOCUMENT.**

1. INTRODUCTION

The Development Bank of Southern Africa (hereafter referred to as “the DBSA” or “the Bank”) seeks the service of academic research expert with a proven track record and extensive experience in the knowledge of development finance and deep understanding of development finance ecosystem, models, and systems.

1.1 DBSA’S Profile

The DBSA is a Development Finance Institutions (DFI) with a sharp focus on infrastructure development, especially in Southern Africa and it is Schedule 2 Public Entity in accordance with the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999).

In terms of the DBSA Act, No 13 of 1997 (Amended Act No 41 of 2014) the Bank is mandated as a DFI with a primary purpose of promoting economic development and sustainable growth, human resource development and institutional capacity building by mobilizing financial and other resources from the national and international private and public sectors for sustainable development projects and programmes in South Africa and the wider African continent.

2. SERVICE REQUIRED

2.1 Context

The DBSA is a Development Finance Institution (DFI) regulated by the DBSA Act, and reports to the Minister of Finance and National Treasury. The DBSA is mandated by the Government of South Africa to provide financial, technical and other assistance to promote economic growth and development, human resource development, institutional capacity building and support development projects in the African continent. The DBSA is a centre of excellence for infrastructure development and is implementing various infrastructure projects on behalf of the Government of South Africa.

Within this context, the DBSA has established development partnerships spanning the globe, as well as partnerships which spans across much of Sub-Saharan Africa.

These partnerships have placed the Bank in an ideal position to take the lead in bridging the divide between public and private sectors in accessing finance in order to amplify both social and economic impact.

One such partnerships is a multilateral relationship with the International Development Finance Club, (IDFC). The IDFC is a network of DFIs of developed countries, governments, domestic development banks in emerging economies and sub-regional DFIs, working together to make steps toward the sustainable development goals by 2030 as well as play a role in impacting the SDGs.

The work of the IDFC is primarily conducted through the establishment of working groups, providing direction in key topics for the club.

On this basis, the DBSA as a member of the IDFC, has been tasked to lead the sub-working group on *Development Finance Architecture*. This sub-working group forms part of the overarching working group on *SDG Alignment Working Group*, which focuses on attainment of the issues of sustainable development via four themes:

- Governance & Regulation
- Framework
- Business Model
- Development Finance Architecture

2.2 Objectives and purpose of the Assignment

Through this initiative the DBSA will be able to support eight of the United Nations 17 Sustainable Development Goals, (SDGs).

The development finance architecture has to be made more coherent and efficient, and transformed into a system that makes optimal use of the different benefits of the various types of development banks (multilateral, international, regional and national/local).

Some of the prevailing paradigms regarding this architecture are decades old and ought to be reassessed. Of particular consideration is the facilitation of direct access to international resources from both international capital markets and public finance by local development banks, which are often the best placed to redirect investment towards the SDGs.

One objective of this research component is to explore how to ensure sufficient, stable and affordable funding sources of DFIs to enable attainment of the SGs. The study will seek to identify diverse funding patterns of DFIs, explain variation in the funding patterns, and propose solutions for increasing funding.

2.2 Scope of Work

The DBSA requests consultancy support of an academic development finance specialist.

The main reason for the assignment is to support the DBSA in undertaking study on the international development finance architecture in order to:

- Map the current state of play within the current development finance architecture
- Identify the challenges and gaps
- Analyze key findings and observations
- Provide tangible recommendations which can be taken up for implementation at regional and national level.

2.3 Deliverables

- The key deliverable will be in the form of a policy position paper which will examine the key challenges within the current development finance architecture ecosystem, identify the gaps and duplications within the system, propose the type of coordination and coherence of actors at global, regional and local level. Which includes analysis of results and with tangible recommendations for implementation.
- Preparation of power point presentation to support the position paper, which lays out the background, objectives, benefits, analysis and outcomes of the study and recommendations.

3.1 Required Expertise & Qualification

- Minimum qualification Requirements - PhD qualification in the area of in Economic Development, Economics and Finance, and/or development finance.
- Must be knowledgeable in the subject of development finance and possess a sound understanding of the global development finance architecture.
- At least 10 years of professional experience in conducting academic research on the topic of economic development and/or development finance
- Demonstrated experience in capacity development initiatives, notably at the systemic and institutional levels;
- Extensive conceptual and practical knowledge of development finance structures, systems, and challenges, etc.
- Demonstrated ability of analytical and report drafting work;

- Advise and input on the development of questionnaire
- Analyze case studies
- Position paper
- Power point presentation
- Participation in academic research work stream meetings Participate and working group meetings where matters relevant to the deliverables are discussed.
