Page 53: Text in the first paragraph incorrectly referring to the "*..development / updating of Water Services Development Plans (WSDP) or Water Services Master Plans in the municipal sphere over the past 10 years..*" has been corrected to read as **development of infrastructure master plans in the built environment (e.g. for human settlements, industrial / commercial developments, water, sanitation, electricity, roads, storm water, etc.) in the past 10 years in South Africa** so as to be consistent with the wording used throughout the document.
