AMENDMENT TO THE TENDER DOCUMENT:

The addendum issued by the DBSA on the 26 January 2022 has the following amendments:

1. Pricing Schedule

The published pricing schedule indicated that bidders are to fully quote for the following phases as stated in the published RFP319/2021:

- a. Phase 1 – Design/Assessment
- b. Phase 2 – Implementation of Minimum Viable Product
- c. Phase 3 – Implementation of the rest of the product

- A reasonable assumption of certain aspects of the RFP is allowed in order to provide indicative pricing for phase two (2) and phase three (3).
- The DBSA will set a threshold for the revised price based on prescribed guidelines by National Treasury.
- Bidders are then required to provide pricing on all three (3) phases. The published pricing schedule remains unchanged.
