- 1.2. ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED- (NOT TO BE RE-TYPED) OR ONLINE
- 1.3. BIDDERS MUST REGISTER ON THE CENTRAL SUPPLIER DATABASE (CSD) TO UPLOAD MANDATORY INFORMATION NAMELY: (BUSINESS REGISTRATION/ DIRECTORSHIP/ MEMBERSHIP/IDENTITY NUMBERS; TAX COMPLIANCE STATUS; AND BANKING INFORMATION FOR VERIFICATION PURPOSES). - 1.14. ALL PRICES MUST BE QUOTED IN SOUTH AFRICAN RAND (ZAR)
- 1.15. THE COST OF MARKETING AND ADVERTISING, AND OTHER CHARGES MUST BE INCLUDED IN THE TOTAL PRICE QUOTED, IF THESE ITEMS ARE REQUESTED AS PART OF THE DBSA COST TEMPLATE / MODEL OF THIS RFQ. TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO CONDUCT A BOARD PERFORMANCE EVALUATION

1. **CONTEXT**

The Development Bank of Southern Africa ("the Bank") is a Development Finance Institution ("DFI") wholly owned by the Government of the Republic of South Africa ("the shareholder"), with a mandate to finance infrastructure projects across Africa. The Bank has positioned itself as a Development Finance Institution ("DFI") that champions and leads infrastructure integration and development. The Bank has sought to promote economic and social development by mobilising financial and other resources from the national and international, private and public sectors, for sustainable development projects in South Africa, the Southern African Development Community (SADC) region and the whole of the African continent. In broad and aspirational terms, the Bank has the vision of a prosperous and integrated resource-efficient region, progressively free of poverty and dependency. As the focal point and custodians of corporate governance, there is a direct correlation between the performance of the Board and the performance of the organisation under which it provides oversight over. Board culture similarly influences the organisational culture, and it is thus important to assess and develop the culture that is wanted at all levels. Continuous performance assessments provide the Board with an opportunity to review and improve its performance. A rigorous Board evaluation allows the Board to reflect on its roles and responsibilities, its culture and its relationship with management.

King IV under Principle 9 provides that the Board should ensure that the evaluation of its own performance and that of its committees, its chair and its individual members, support continued improvement in its performance and effectiveness. King IV™ recommends that the board conducts a formal performance evaluation every two years, and during the alternate year, the board should schedule in its annual work plan an opportunity to consider, reflect and discuss its performance.

2. PURPOSE

The purpose of this Terms of Reference ("ToR") is to appoint an independent professional service provider to evaluate the DBSA's Board performance and that of its committees, its chair and its individual members to support the continued improvement of the Board performance and effectiveness. The evaluation will amongst other help the Board to improve the effectiveness of the leadership and governance of the Bank and give the Board the opportunity to "reflect on its performance" in the pursuit of fulfilling its role.

3. SCOPE OF WORK

The requirements listed below are for guidance only, and are not exhaustive:

- Develop a detailed appropriate methodology to be used to conduct the Board Performance Evaluation and a work implementation plan.
- Examine the roles and responsibilities of the Board, the effectiveness of its committees and its relationship with key governance players and overall assess the key areas which impact its effectiveness including all associated processes and documentation, e.g. Board and Committee charters, Board and Committee composition and administrative support.
- Assess the competencies of the members (Skills gap analysis).
- Self-evaluation and individual directors' Peer Review.
 Engage with the Board of Directors to establish their views on several governance processes and Board dynamics.

4. **DELIVERABLES**

- A report containing the results of the Board appraisal should be provided. The report should highlight the areas of good and satisfactory performance and those that require improvement. The report must include an action plan to improve performance and or process for those areas identified as requiring improvement.
- A report containing the results of the skills gap analysis should be provided and must include a recommendation on the continuous development plan that should be undertaken by each Board member and or a recommendation to close the identified skills gaps.
- A report containing the results of the Board's self-evaluation and individual directors' peer review on the performance of each other.
- A high-level overview of the results of the appraisal should be presented to the Board.
- A Board Development Framework and Action Plan must be provided for the ensuing financial year based on the outcomes of Board evaluation, self-evaluation and peer review.
- Design and facilitate a half-day corporate governance training workshop for the Board based on the evaluation's key theme.

5. REQUIREMENTS AND SPECIFICATIONS FOR THE PROJECT

The independent professional service provider should have the following expertise:

- A minimum of ten (10) years of demonstrable experience in corporate governance and conducting tailored appraisals and evaluations of Boards of medium to large size organizations, in the private and public sectors, banking/DFIs/finance/State Owned Enterprises (SoE).
- Proven track record in carrying out a Board evaluation exercise of medium to large size organizations, in the private and public sectors, banking/DFIs/finance/SoE.
- Deep, proven knowledge of corporate governance best practices and standards.

Failure to submit these documents will invalidate the bid.
