ANNEXURE A

Terms of Reference

Background

The Development Bank of Southern Africa (DBSA) is one of Africa's leading Development Finance Institutions (DFIs) in infrastructure financing, planning, project preparation and institutional development for municipal infrastructure. Owned by the Government of South Africa, the DBSA seeks to support the shareholder's social and economic development imperatives partnering with both the public and the private sectors.

Information and Communications Technology (ICT) is a critical enabler of economic growth. DBSA's ICT infrastructure portfolio significantly lags those in its other mandated economic sectors, and the ICT coverage and origination unit now seeks to accelerate its ICT-related funding activities, with a view of investing in ICT segments that ultimately balance sound commercial return and development impact, particularly in underserved market segments.

To achieve this, the ICT unit requires a comprehensive ICT market study that provides a market overview of the global, regional, and domestic ICT market. In addition to mapping the ICT ecosystem, the study is required to help identify the most attractive market segments of the ICT landscape for investment, map out the key industry participants in each segment, including a SWOT analysis, key strategic focus areas and a go-to-market strategy plan.
