THE TERMS OF REFERENCE AND PROJECT BRIEF: THE APPOINTMENT OF A PROFESSIONAL SERVICE PROVIDER (PSP) TO PROVIDE THE DBSA WITH SERVICES TO REPLACE ALL DAMAGED WINDOWS, EXTERIOR WOODEN AND STEEL ROLLER DOORS.

1. Introduction

The Development Bank of Southern Africa (DBSA) is one of Africa's leading Development Finance Institutions (DFIs) in infrastructure financing, planning, project preparation and institutional development for municipal infrastructure. Owned by the Government of South Africa, the DBSA seeks to support the shareholder's social and economic development imperatives partnering with both the public and the private sectors.

2. Background

In keeping with the DBSA facility management agenda and provision of world class facilities services, the DBSA seeks professional service provider to provide the Bank with the replacement services of aluminium frames, doors and safety glasses

3. PROJECT OBJECTIVES

- Aluminium material shall be of 6063-T6 alloy and temper, and the profile must be designed to meet the required structural integrity for wind load as per NBR (Nitrile Butadiene Rubber)
- Service provider must submit material data sheet for the aluminium material required before resuming with the service and failing to provide the data sheet the DBSA will therefore indefinitely cancel the appointment letter.
- All double solid doors must have flush bolt top and bottom.
- Service provider shall carry the cost of any damage occurred during the project.
- All kitchen doors must have one shooter
- Door handle must of standard premium aluminium bronze spring-loaded.
- Remove and replace existing damaged exterior wooden doors with Bronx brown colour.
- All glasses shall be of 4mm to 6mm shatterproof safety glass.
- All roller doors must use a Push button Station up down arrows with top button.
- Gently remove existing steel door frame and replace it with aluminium frame
- Replace all existing steel roller doors.
- All cylinder lock must have master key (Facilities will provide sample of Union Master key cylinder).
- Due to the nature of work DBSA might request the service provider to work on weekend there the labour charge rate must include of weekend hours.
- No material will leave the DBSA campus without signed pass out from facilities and security department.
- Service provider must provide working contractors generator for loadshedding purposes.
