**APPOINTMENT OF A SERVICE PROVIDER FOR RECORDS STORAGE MANAGEMENT FOR THE
INDEPENDENT POWER PRODUCERS' OFFICE FOR 3YEARS**

1. INTRODUCTION

The Department of Mineral Resources and Energy (DMRE), National Treasury (NT) and the Development Bank of Southern Africa (DBSA) established the Independent Power Producers Office (IPPO) for the specific purpose of delivering on the IPPPP objectives.

The programme's primary mandate is to secure electrical energy from the private sector for renewable and non-renewable energy sources. With regard to renewables, the programme is designed to reduce the country's reliance on fossil fuels, stimulate an indigenous renewable energy industry and contribute to socio-economic development and environmentally sustainable growth.

The IPPO currently occupies office space within the Bylsbridge Office Park, Centurion.

2. PURPOSE

The purpose of the request is to appoint a service provider to provide off-site storage facilities to render document management services for the IPPO in line with the provisions of the National Archives and Records Services SA with the applicable National Archives and records Service Act (Act No 43 of 1996) for a period of thirty six 36 months.

3. SCOPE OF WORK

3.1 Provision of Document Storage and Collection Services

The prospective bidder is required to provide off-site storage facilities and to render document management services for the IPPO in line with the provisions of the National Archives Act 43 of 1996 for a period of thirty six (36) months.

The prospective bidder is expected to provide a comprehensive and reliable off-site records archiving, retrieval and destruction service, comprising of the following:

- A records management system to enable the tracking and retrieval of documents;
- Retrieval services of records archived at the off-site storage facility and delivery to the IPPO as and when required;
- The provision of storage boxes and relevant tracking labels for the records to be transferred;
- The collection and removal (delivery/transportation) of records, boxes and files from the IPPO to the off-site storage facility, as and when required;
- Destruction and disposal services;

- Relocation of the existing records and files from the current off-site storage to the new off-site storage facility – the number of boxes from the current service provider off-site storage is estimated at 799.
- Relocation of the existing records and files from the IPPO to the new off-site storage – the number of boxes from the current service provider off-site storage is estimated at 700.
- Scheduled return or collection of sealed boxes containing records and files on request as required by the IPPO.
 - Urgent Same Day
 - Urgent Next Day

3.2 *Requirements*

3.2.1 Confirmation of compliance

Provide proof that the service provider's processes is credible and compliant with the following:

- Compliance letter related to National Archives Act 43 of 1996 ; and
- I-SIGMA Membership Certificate or similar membership.

- Return and collection of boxes;
