- 1.4 **Business Day** means a day which is not a Saturday, Sunday or public holiday in South Africa.
- 1.5 **Bid** means a written offer in the prescribed or stipulated form lodged by a Bidder in response to an invitation in this Request for Proposal, containing an offer to provide goods, works or services in accordance with the Specification as provided in this RFP.
- 1.6 **Bidder** means a person or legal entity, or an unincorporated group of persons or legal entities that submit a Bid.
- 1.7 **Companies Act** means the Companies Act, 2008.
- 1.8 **Compulsory Documents** means the list of compulsory schedules and documents set out in Part B.
- 1.9 **Closing Time** for the OneDrive Link submissions - 23h55 on the 01 March 2024 (Telkom Time)
- 1.10 **DBSA** means the Development Bank of Southern Africa Limited.

6. STATUS OF REQUEST FOR PROPOSAL

- 6.1 This RFP is an invitation for person(s) to submit a proposal(s) for the provision of the services as set out in the Specification contained in this RFP. Accordingly, this RFP must not be construed, interpreted, or relied upon, whether expressly or implicitly, as an offer capable of acceptance by any person(s), or as creating any form of contractual, promissory or other rights. No binding contract or other understanding for the supply of services will exist between the DBSA and any Bidder unless and until the DBSA has executed a formal written contract with the successful Bidder.

7. ACCURACY OF REQUEST FOR PROPOSAL

- 7.1 Whilst all due care has been taken in connection with the preparation of this RFP, the DBSA makes no representations or warranties that the content in this RFP or any information communicated to or provided to Bidders during the Tendering Process is, or will be, accurate, current or complete. The DBSA, and its officers, employees and advisors will not be liable with respect to any information communicated which is not accurate, current or complete.
- 7.2 If a Bidder finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this RFP or any other information provided by the DBSA (other than minor clerical matters), the Bidder must promptly notify the DBSA in writing of such discrepancy, ambiguity, error or inconsistency in order to afford the DBSA an opportunity to consider what corrective action is necessary (if any).
- 7.3 Any actual discrepancy, ambiguity, error or inconsistency in this RFP or any other information provided by the DBSA will, if possible, be corrected and provided to all Bidders without attribution to the Bidder who provided the written notice.

8. ADDITIONS AND AMENDMENTS TO THE RFP

- 8.1 The DBSA reserves the right to change any information in, or to issue any addendum to this RFP before the Closing Time. The DBSA and its officers, employees and advisors will not be liable in connection with either the exercise of, or failure to exercise this right.
- 8.2 If the DBSA exercises its right to change information in terms of clause 8.1, it may seek amended Tenders from all Bidders.

9. REPRESENTATIONS

No representations made by or on behalf of the DBSA in relation to this RFP will be binding on the DBSA unless that representation is expressly incorporated into the contract ultimately entered between the DBSA and the successful Bidder.

10. CONFIDENTIALITY

10.1 All persons (including all Bidders) obtaining or receiving this RFP and any other information in connection with this RFP or the Tendering Process must keep the contents of the RFP and other such information confidential, and not disclose or use the information except as required for the purpose of developing a proposal in response to this RFP.

11. REQUESTS FOR CLARIFICATION OR FURTHER INFORMATION

- 11.1 All communications relating to this RFP and the Tendering Process must be directed to the Tender Officer.
- 11.2 All questions or requests for further information or clarification of this RFP or any other document issued in connection with the Tendering Process must be submitted to the Tender Officer in writing, and most preferably by e-mail to davidscm@dbsa.org
- 11.3 Any communication by a Bidder to the DBSA will be effective upon receipt by the Tender Officer (provided such communication is in the required format).
- 11.4 The DBSA has restricted the period during which it will accept questions or requests for further information or clarification and reserves the right not to respond to any enquiry or request, irrespective of when such enquiry or request is received.
- 11.5 Except where the DBSA is of the opinion that issues raised apply only to an individual Bidder, questions submitted and answers provided will be made available to all Bidders by e-mail, as well as on the DBSA's website without identifying the person or organisation which submitted the question.
- 11.6 In all other instances, the DBSA may directly provide any written notification or response to a Bidder by email to the address of the Bidder (as notified by the Bidder to the Tender Manager).
- 11.7 A Bidder may, by notifying the Tender Officer in writing, withdraw a question submitted in accordance with clause 12, in circumstances where the Bidder does not wish the DBSA to publish its response to the question to all Bidders.

12. UNAUTHORISED COMMUNICATIONS

- 12.1 Communications (including promotional or advertising activities) with staff of the DBSA or their advisors assisting with the Tendering Process are not permitted during the Tendering Process, or otherwise with the prior consent of the Tender Officer. Nothing in this clause 12 is intended to prevent communications with staff of, or advisors to, the DBSA to the extent that such communications do not relate to this RFP or the Tendering Process.
- 12.2 Bidders must not otherwise engage in any activities that may be perceived as, or that may have the effect of, influencing the outcomes of the Tendering Process in any way.

13. IMPROPER ASSISTANCE, FRAUD AND CORRUPTION

- 13.1 Bidders may not seek or obtain the assistance of employees of the DBSA in the preparation of their tender responses.
- 13.2 The DBSA may in its absolute discretion, immediately disqualify a Bidder that it believes has sought or obtained such improper assistance.
- 13.3 Bidders are to be familiar with the implications of contravening the Prevention and Combating of Corrupt Activities Act, 2004 and any other relevant legislation.

14. ANTI-COMPETITIVE CONDUCT

- 14.1 Bidders and their respective officers, employees, agents and advisors must not engage in any collusion, anti-competitive conduct or any other similar conduct in respect of this Tendering Process with any other Bidder or any other person(s) in relation to:
 - 14.1.1 the preparation or lodgement of their Bid
 - 14.1.2 the evaluation and clarification of their Bid; and
 - 14.1.3 the conduct of negotiations with the DBSA.
- 14.2 For the purposes of this clause 14, collusion, anti-competitive conduct or any other similar conduct may include disclosure, exchange and clarification of information whether or not such information is confidential to the DBSA or any other Bidder or any other person or organisation.
- 14.3 In addition to any other remedies available to it under law or contract, the DBSA may, in its absolute discretion, immediately disqualify a Bidder that it believes has engaged in any collusive, anti-competitive conduct or any other similar conduct during or before the Tendering Process.

15. COMPLAINTS ABOUT THE TENDERING PROCESS

- 15.2 The written complaint must set out:
- 15.2.1 the basis for the complaint, specifying the issues involved;
 - 15.2.2 how the subject of the complaint affects the organisation or person making the complaint;
 - 15.2.3 any relevant background information; and
 - 15.2.4 the outcome desired by the person or organisation making the complaint.
- 15.3 If the matter relates to the conduct of an employee of the DBSA, the complaint should be addressed in writing marked for the attention of the Chief Executive Officer of the DBSA, and delivered to the physical address of the DBSA, as notified.

16. CONFLICT OF INTEREST

- 16.1 A Bidder must not, and must ensure that its officers, employees, agents and advisors do not place themselves in a position that may give rise to actual, potential or perceived conflict of interest between the interests of the DBSA and the Bidder's interests during the Tender Process.
- 16.2 The Bidder is required to provide details of any interests, relationships or clients which may or do give rise to a conflict of interest in relation to the supply of the services under any contract that may result from this RFP. If the Bidder submits its Bid and a subsequent conflict of interest arises, or is likely to arise, which was not disclosed in the Bid, the Bidder must notify the DBSA immediately in writing of that conflict.
- 16.3 The DBSA may immediately disqualify a Bidder from the Tendering Process if the Bidder fails to notify the DBSA of the conflict as required.

17. LATE BIDS

- 17.1 Bids must be delivered by the Closing Time. The Closing Time may be extended by the DBSA in its absolute discretion by providing written notice to Bidders.
- 17.2 Bids delivered after the Closing Time or lodged at a location or in a manner that is contrary to that specified in this RFP will be disqualified from the Tendering Process and will be ineligible for consideration. However, a late Bid may be accepted where the Bidder can clearly demonstrate (to the satisfaction of the DBSA, in its sole discretion) that late lodgement of the Bid was caused by the DBSA; that access was denied or hindered in relation to the physical

tender box; or that a major/critical incident hindered the delivery of the Bid and, in all cases, that the integrity of the Tendering Process will not be compromised by accepting a Bid after the Closing Time.

- 17.3 The determination of the DBSA as to the actual time that a Bid is lodged is final. Subject to clause 17.2, all Bids lodged after the Closing Time will be recorded by the DBSA and will only be opened for the purposes of identifying a business name and address of the Bidder. The DBSA will inform a Bidder whose Bid was lodged after the Closing Time of its ineligibility for consideration. The general operating practice is for the late Bid to be returned within 5 (five) working days of receipt or within 5 (five) working days after determination not to accept a late Bid.

18. BIDDER'S RESPONSIBILITIES

- 18.1 Bidders are responsible for:

- 18.1.1 examining this RFP and any documents referenced or attached to this RFP and any other information made or to be made available by the DBSA to Bidders in connection with this RFP;
- 18.1.2 fully informing themselves in relation to all matters arising from this RFP, including all matters regarding the DBSA's requirements for the provision of the Services;
- 18.1.3 ensuring that their Bids are accurate and complete;
- 18.1.4 making their own enquiries and assessing all risks regarding this RFP, and fully considering and incorporating the impact of any known and unknown risks into their Bid;
- 18.1.5 ensuring that they comply with all applicable laws in regard to the Tendering Process particularly as specified by National Treasury Regulations, Guidelines, Instruction Notes and Practice Notes and other relevant legislation as published from time to time in the Government Gazette; and
- 18.1.6 submitting all Compulsory Documents.

- 18.2 South African bidders with annual total revenue of ZAR10 million or less qualify as Exempted Micro Enterprises (EMEs) in terms of the B-BBEE Act must submit a certificate issued by a registered, independent auditor (who or which is not the Bidder or a part of the Bidder) or an accredited verification agency.

- 18.3 South African bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy, or a sworn affidavit thereof, substantiating their B-BBEE status. The submission of such certificates must comply with the requirements of instructions and guidelines issued by National Treasury and be in accordance with the

applicable notices published by the Department of Trade and Industry in the Government Gazette.

- 18.4 The DBSA reserves the right to require of a Bidder, either before a Bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the DBSA.
- 18.5 Failure to provide the required information may result in disqualification of the Bidder.

19. PREPARATION OF BIDS

- 19.1 Bidders must ensure that:

- 19.1.1 their Bid is submitted in the required format as stipulated in this RFP; and
 - 19.1.2 all the required information fields in the Bid are completed in full and contain the information requested by the DBSA.

- 19.2 The DBSA may in its absolute discretion reject a Bid that does not include the information requested or is not in the format required.
- 19.3 Unnecessarily elaborate responses or other representations beyond that which is sufficient to present a complete and effective tender proposal are not desired or required. Elaborate and expensive visual and other presentation aids are not necessary.
- 19.4 Where the Bidder is unwilling to accept a specified condition, the non-acceptance must be clearly and expressly stated. Prominence must be given to the statement detailing the non-acceptance. It is not sufficient that the statement appears only as part of an attachment to the Bid or be included in a general statement of the Bidders usual operating conditions.
- 19.5 An incomplete Bid may be disqualified or assessed solely on the information completed or received with the Bid.

20. ILLEGIBLE CONTENT, ALTERATION AND ERASURES

- 20.1 Incomplete Bids may be disqualified or evaluated solely on information contained in the Bid.
- 20.2 The DBSA may disregard any content in a Tender that is illegible and will be under no obligation whatsoever to seek clarification from the Bidder.
- 20.3 The DBSA may permit a Bidder to correct an unintentional error in its Bid where that error becomes known or apparent after the Closing Time, but in no event will any correction be permitted if the DBSA reasonably considers that the correction would materially alter the substance of the Bid or effect the fairness of the Tendering Process.

21. OBLIGATION TO NOTIFY ERRORS

If, after a Bidder's Response has been submitted, the Bidder becomes aware of an error in the Bidders Response (including an error in pricing but excluding clerical errors which would have no bearing on the evaluation of the Bid), the Bidder must promptly notify the DBSA of such error.

22. RESPONSIBILITY FOR BIDDING COSTS

22.1 The Bidders participation or involvement in any stage of the Tendering Process is at the Bidders sole risk, cost and expense. The DBSA will not be held responsible for, or pay for, any expense or loss that may be incurred by Bidders in relation to the preparation or lodgement of their Bid.

22.2 The DBSA is not liable to the Bidder for any costs on the basis of any contractual, promissory or restitutionary grounds whatsoever as a consequence of any matter relating to the Bidders participation in the Tendering Process, including without limitation, instances where:

22.2.1 the Bidder is not engaged to perform under any contract; or

22.2.2 the DBSA exercises any right under this RFP or at law.

23. DISCLOSURE OF BID CONTENTS AND BID INFORMATION

23.1 All Bids received by the DBSA will be treated as confidential. The DBSA will not disclose contents of any Bid and Bid information, except:

23.1.1 as required by law;

23.1.2 for the purpose of investigations by other government authorities having relevant jurisdiction;

23.1.3 to external consultants and advisors of the DBSA engaged to assist with the Tendering Process; or for the general information of Bidders required to be disclosed as per National Treasury Regulations, Guidelines, Instruction Notes or Practice Notes.

24. USE OF BIDS

24.1 Upon submission in accordance with the requirements relating to the submission of Bids, all Bids submitted become the property of the DBSA. Bidders will retain all ownership rights in any intellectual property contained in the Bids.

24.2 Each Bidder, by submission of their Bid, is deemed to have licensed the DBSA to reproduce the whole, or any portion, of their Bid for the sole purposes of enabling the DBSA to evaluate the Bid.

25. BID ACCEPTANCE

All Bids received must remain open for acceptance for a minimum period of 120 (one-hundred and twenty) days from the Closing Date and Time. This period may be extended by written mutual agreement between the DBSA and the Bidder.

26. EVALUATION PROCESS

26.1 The Bids will be evaluated and adjudicated as follows:

26.1.1 First Stage – Test for administrative Responsiveness

The test for administrative responsiveness will include the following:

Stage 1: Responsiveness

The Tenderer should be able to provide all the relevant information required in the Supplier Information Form (SIF) which will include but not limited to;

A. Tenderers who do not adhere to those criteria listed a PRE-QUALIFIER, will be disqualified immediately.

Only those Bidders which satisfy all the Pre-Qualifying Criteria of the First Stage will be eligible to participate in the Tendering Process further. Bids which do not satisfy all the Pre-Qualifying Criteria of the First Stage will not be evaluated further.

26.1.2 Second Stage – Functional criteria

26.1.1 Only those Bidders who score **[80]** points or higher (out of a possible 100) during the functional evaluation of the Second Stage will be evaluated further. Bidders are required to submit supporting documentation evidencing their compliance with each requirement, where applicable.

Bidders will be assessed on the functional criteria (Second Stage) as set out in this RFP. Only those Bidders which comply with the eligibility criteria will proceed to the Third Stage.

26.1.2 Third Stage – price

26.1.2.1 Those Bidders which have passed the First Stage (Responsiveness Test) and Second Stage (Functional Evaluation) of the tender process will be eligible to be evaluated on the Third Stage, based on price, in accordance with the PPPFA regulations.

26.1.2.2 The recommended preferred Bidder will be the Bidder with the lowest overall price in the Third Stage of the Bid evaluation, unless the DBSA exercises its right to cancel the RFP, in line with the PPPFA Regulations.

26.2 NB: Bidders are required to submit, as Annexure J to their Bids, any documentation which supports the responses provided in respect of the Eligibility Criteria below.

26.3 First Stage: Pre-Qualifying Criteria

Only those Bidders which satisfy all the Pre-Qualifying Criteria will be eligible to participate in the Tendering Process further. Bids which do not satisfy all the Pre-Qualifying Criteria will not be evaluated further. Please refer to the table above

Note: A tender that fails to meet any Pre-Qualifying Criteria stipulated herein in the tender documents is an unacceptable tender. Please refer to the table above

26.4 Second Stage: Functional Criteria

The technical proposal will be evaluated according to the following criteria and scoring system. The technical score will be calculated out of 100 points, and only those bids that achieve a threshold of **80** points for the technical proposal will move to the next level of evaluation where a score for price and BBBEE.

26.5 A minimum of 80 points out of a 100 for the functional evaluation will qualify the Bid to move on to the Third Stage of evaluation, which is price and preferential point's evaluation.

26.6 Bidders that do not score **80** points (inclusive of the presentation) or higher at this stage of the evaluation will not be evaluated during the Third Stage of the evaluation.

26.7 Third Stage: Price

26.7.1 The Third Stage of evaluation of the Bids will be in respect of price and preference.

27. Risk Analysis and Objective Criteria

Risk Analysis and Objective Criteria *(This must only be included in the tender document if it is applicable, ensure that the list is specific as to what your objective criteria are)*

The DBSA reserves the right to award the tender to the tenderer who scores the highest number of points overall in line with Section (2) (1) (f) of the PPPFA, unless there are objective criteria which will justify the award of the tender to another tenderer. The objective criteria that the DBSA may apply in this bid process includes:

- i. Any bidder that has a cumulative order book totaling 3 Awards with outstanding value, **may be excluded from further evaluation.**
- ii. Where a bidder has 3 active Awards with an outstanding value and the outstanding value is 10% or less, indicating the project is nearing completion, the bidder may be included **for further evaluation and/or recommendation for award.**
- iii. Where a bidder has 3 active Awards with an outstanding value and at least one of the projects has stalled for a period of 6 months or more, or the client has placed the project on hold indefinitely, the bidder may be included **for further evaluation and/or recommendation for award.**
- iv. The DBSA has the discretion to apply an objective criterion.

28. Due Diligence

DBSA shall perform a due diligence exercise on the preferred bidder to determine its risk profile. The due diligence exercise may take the following factors into account inter alia.

a. Judgements and criminal convictions

DBSA may consider previous civil judgements against the preferred bidder as part of its risk assessment. DBSA may also consider whether the preferred bidder or any of its directors have been convicted of a serious offence.

b. Pending litigation/liquidation/business rescue (distinct from Working Capital)

DBSA may consider any pending litigation in a court of law or administrative tribunal as part of its risk assessment.

c. Performance

DBSA will not consider the Service provider having a history of poor performance on any task orders/purchase orders or contracts, including poor performance in respect of compliance with policies or procedures regarding safety, health, quality control or environment, or having committed a serious and gross breach of contract.

d. Reputational harm

If DBSA is likely to suffer substantial reputational harm because of doing business with the preferred service provider, it may take this into account as part of its risk assessment.

e. Restricted/Blacklisted

Is not under restrictions, or has principals who are under restrictions, preventing participating in the employer's procurement.

f. Vetting

The DBSA reserves the right to conduct vetting on the tenderer or any of its directors.

- g. PEP Checks for both Companies and Individual directors, as well as Procure Check and or any other systems that the DBSA may choose to utilize (which may be conducted by an authorized third party) that would be done to assess all risks, including but not limited to

- a. Financial stability of the bidder based on key ratio analysis ;
- b. Efficiency ;

- c. Profitability ;
 - d. Financial Risk;
 - e. Liquidity ;
 - f. Acid Test ;
 - g. Solvency; and
 - h. Commercial relationship with a politically exposed and brand risk
 - i. The DBSA reserves the right to award the scope in full or part thereof, subject to budget availability.
 - ii. The DBSA reserves the right to negotiate to ensure the value for money principle is not compromised.
- 29.** Generally, suppliers have their own business standards and regulations. Although DBSA cannot control the actions of our suppliers, we will not tolerate any Illegal activities. These include, but are not limited to:
- Misrepresentation of any kind (e.g. origin of manufacture, specifications, intellectual property rights, etc.);
 - Collusion;
 - Failure to disclose accurate information required during the sourcing activity (ownership, financial situation, BBBEE status, etc.);
 - Corrupt activities listed above; and
 - Harassment, intimidation or other aggressive actions towards DBSA's employees.
- 30. STATUS OF BID**
- 30.1 Each Bid constitutes an irrevocable offer by the Bidder to the DBSA to provide the Services required and otherwise to satisfy the requirements of the Specification as set out in this RFP.
- 30.2 A Bid must not be conditional on:
- 30.2.1 the Board approval of the Bidder or any related governing body of the Bidder being obtained.
 - 30.2.2 the Bidder conducting due diligence or any other form of enquiry or investigation.
 - 30.2.3 the Bidder (or any other party) obtaining any regulatory approval or consent.
 - 30.2.4 the Bidder obtaining the consent or approval of any third party; or
 - 30.2.5 the Bidder stating that it wishes to discuss or negotiate any commercial terms of the contract.
- 30.3 The DBSA may, in its absolute discretion, disregard any Bid that is, or is stated to be, subject to any one or more of the conditions detailed above (or any other relevant conditions).
- 30.4 The DBSA reserves the right to accept a Bid in part or in whole or to negotiate with a Bidder in accordance with the provisions of this RFP and the applicable laws and regulations.

31. CLARIFICATION OF BIDS

- 31.1 The DBSA may seek clarification from and enter into discussions with any or all of the Bidders in relation to their Bid. The DBSA may use the information obtained when clarification is sought

or discussions are held in interpreting the Bid and evaluating the cost and risk of accepting the Bid. Failure to supply clarification to the satisfaction of the DBSA may render the Bid liable to disqualification.

- 31.2 The DBSA is under no obligation to seek clarification of anything in a Bid and reserves the right to disregard any clarification that the DBSA considers to be unsolicited or otherwise impermissible or irrelevant in accordance with the rules set out in this RFP.

32. DISCUSSION WITH BIDDERS

- 32.1 The DBSA may elect to engage in detailed discussions with any one or more Bidder(s), with a view to maximising the benefits of this RFP as measured against the evaluation criteria and in fully understanding a Bidder's offer.
- 32.2 Where applicable, the DBSA will invite Bidders to give a presentation to the DBSA in relation to their submissions.
- 32.3 The DBSA is under no obligation to undertake discussions with, and Bidders.
- 32.4 In addition to presentations and discussions, the DBSA may request some or all Bidders to:
- 32.4.1 conduct a site visit, if applicable.
 - 32.4.2 provide references or additional information; and/or
 - 32.4.3 make themselves available for panel interviews.

33. SUCCESSFUL BIDS

- 33.1 Selection as a successful Bidder does not give rise to a contract (express or implied) between the successful Bidder and the DBSA for the supply of the Services. No legal relationship will exist between the DBSA and a successful Bidder for the supply of the Services until such time as a binding contract is executed by them.
- 33.2 The DBSA may, in its absolute discretion, decide not to enter into pre-contractual negotiations with a successful Bidder.
- 33.3 A Bidder is bound by its Bid and all other documents forming part of the Bidder's Response and, if selected as a successful Bidder, must enter into a contract on the basis of the Bid with or without further negotiation.

34. NO OBLIGATION TO ENTER INTO CONTRACT

- 34.1 The DBSA is under no obligation to appoint a successful Bidder or Bidders (as the case may be), or to enter into a contract with a successful Bidder or any other person, if it is unable to identify a Bid that complies in all relevant respects with the requirements of the DBSA, or if due to changed circumstances, there is no longer a need for the Services requested, or if funds are no longer available to cover the total envisaged expenditure. For the avoidance of any doubt, in these circumstances the DBSA will be free to proceed via any alternative process.

- 34.2 The DBSA may conduct a debriefing session for all Bidders (successful and unsuccessful). Attendance at such debriefing session is optional.

35. BIDDER WARRANTIES

- 35.1 By submitting a Bid, a Bidder warrants that:
- 35.1.1 it did not rely on any express or implied statement, warranty or representation, whether oral, written, or otherwise made by or on behalf of the DBSA, its officers, employees, or advisers other than any statement, warranty or representation expressly contained in the RFP;
 - 35.1.2 it did not use the improper assistance of DBSA's employees or information unlawfully obtained from them in compiling its Bid;
 - 35.1.3 it is responsible for all costs and expenses related to the preparation and lodgement of its Bid, any subsequent negotiation, and any future process connected with or relating to the Tendering Process;
 - 35.1.4 it accepts and will comply with the terms set out in this RFP; and
 - 35.1.5 it will provide additional information in a timely manner as requested by the DBSA to clarify any matters contained in the Bid.

36. DBSA'S RIGHTS

- 36.1 Notwithstanding anything else in this RFP, and without limiting its rights at law or otherwise, the DBSA reserves the right, in its absolute discretion at any time, to:

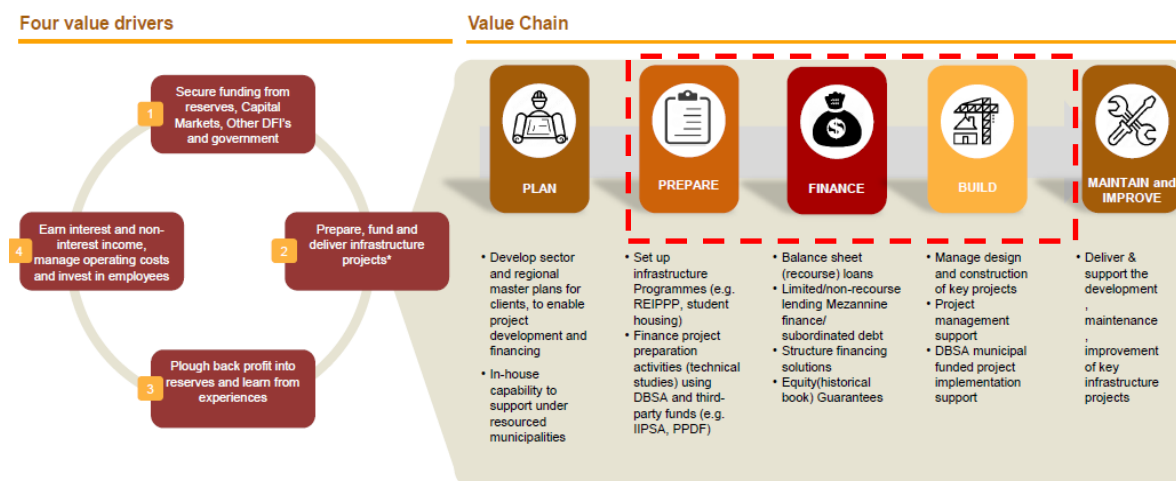
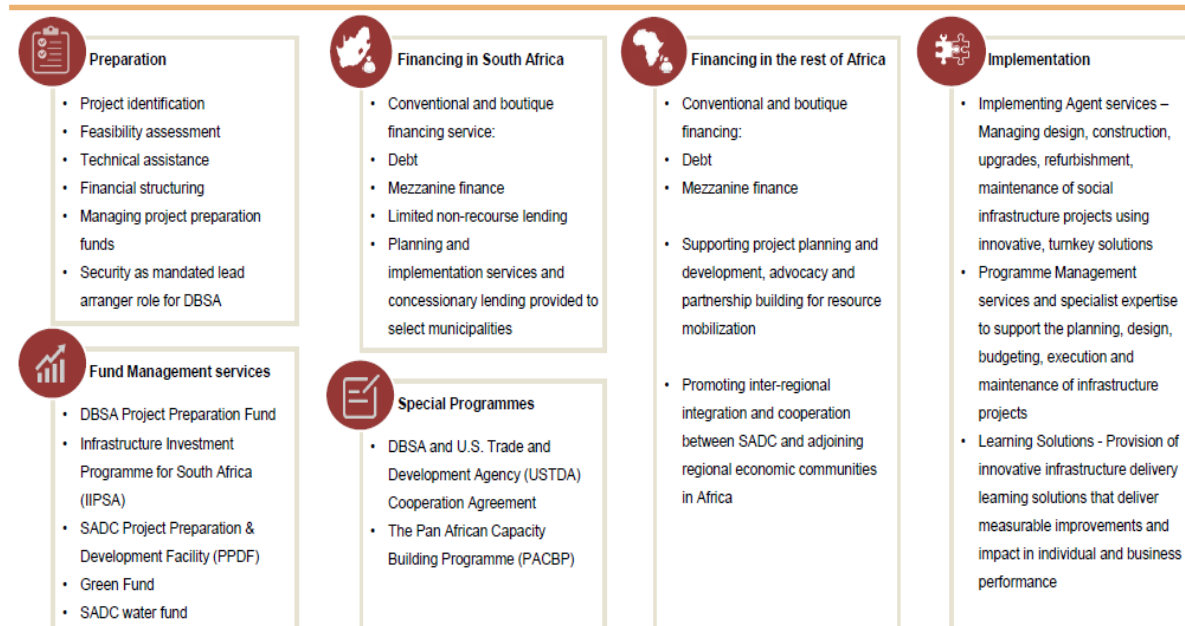


Figure 1: Primary focus areas of the DBSA

1. INTRODUCTION

The Development Bank of Southern Africa (“the Bank” or “DBSA”) is a Development Finance Institution (“DFI”) owned by the Government of the Republic of South Africa (“the Shareholder”), with a mandate to finance infrastructure projects across Africa. The Bank has positioned itself as a DFI that champions and leads infrastructure integration and development. The Bank has sought to promote economic and social development by mobilizing financial and other resources from the national and international, private and public sectors, for sustainable development projects in South Africa, the Southern African Development Community (SADC) region, and the whole of the African continent. In broad and aspirational terms, the Bank has the vision of a prosperous and integrated resource-efficient region, progressively free of poverty and dependency. 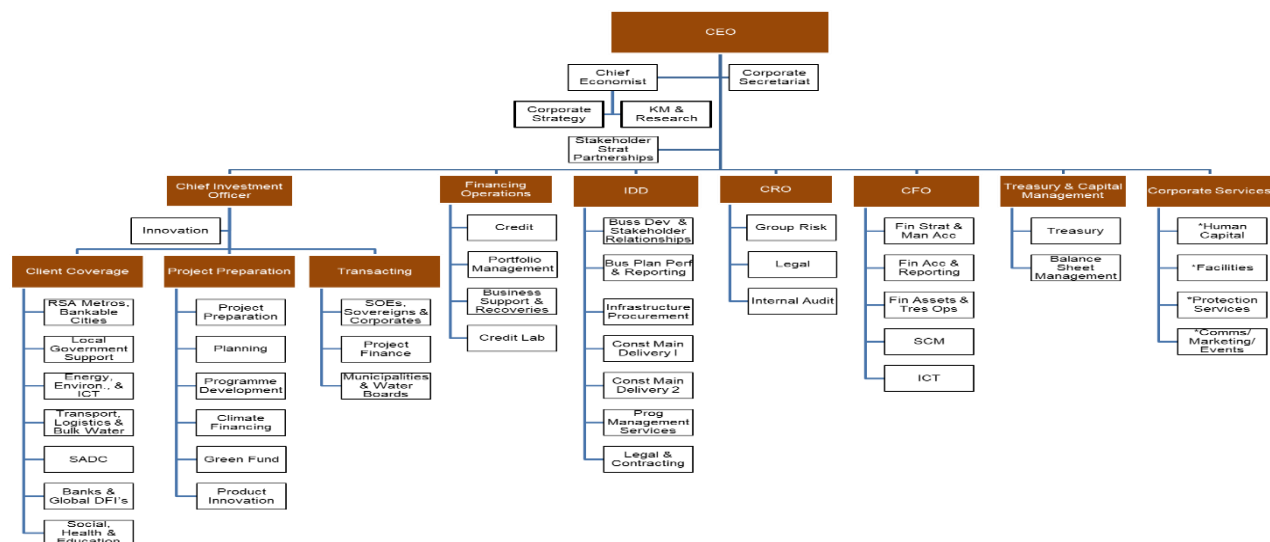
2. CONTEXT

The Board and the Executive Committee have agreed on strategic priorities for the next decade. Most importantly, they have done so without changing the current strategy, focus areas (e.g. sectors) and business of the Bank. Most of the strategic priorities are outward-focused, with a few being inward-focused. The outward-focused ones include the development of strategies, programmes and interventions associated with Environment, Social and Governance (ESG) and Just Transition, amongst others. The Bank will also retain its focus in Metropolitans and Municipalities, implementing interventions such as the front-loading of municipal infrastructure grants in support of increased infrastructure development. The Bank will also review its options regarding the regulatory framework and opt for the most optimal for capital management, that can be institutionalized within the next 3 years.

The inward-focused (that is, internal to the Bank) strategic imperatives are encapsulated under the banner of Future-Fit-DBSA, which for the Bank includes the following: Digitalization, Structural Optimization and Operational Efficiency. This ToR is geared at addressing the latter two aspects of the Future-Fit-DBSA initiative. All that has been mentioned above and more, is captured in the annual Corporate Plan(s) as approved by both the Board and the Shareholder.

As an organization, the Bank has an asset base of circa 110 billion ZAR, a budgeted headcount of circa 730, semi-autonomous programmes which it executes on behalf of other stakeholders (internally termed ‘Agencies’) with an estimated headcount of 80 and retains a graduate cohort of about 40 annually. More details of Bank’s activities and finances are reflected in its Annual Financial Statements, Integrated Annual Reports and Sustainability Review Reports which can be found on the DBSA website at www.dbsa.org

The high-level DBSA structure is as follows:



3. PURPOSE

The purpose of this ToR is to appoint an Independent Service Provider (“ISP”) to support the DBSA in becoming Future-Fit. Specifically, the ISP is to conduct an evaluation of the Bank’s current operating model and associated elements, whereafter it is expected to develop recommendations that will be consulted with the Board as well as the Executive Committee. The conclusion hereof, will be recommendations that the Bank then accepts and implements.

4. DETAILED SCOPE OF THE ASSIGNMENT

The problem statement can be summarized as follows:

The Bank has only had two (2) operating model reviews in the past decade. The first, in and around 2012/3 was initiated by a change in tactical strategy which led to the Bank solutioning differently for both human resources provision as well as the building and maintenance of municipal infrastructure. It furthermore led to the Bank closing one Division (Development Fund) and opening another (Infrastructure Delivery). The second, in and around 2017/8 was again initiated in response to another change in tactical strategy. This time the focus was on the front-office Divisions and led to the structures as well as execution value chain that are currently in use. For example, two distinct Divisions, focused on the national (SA) as well as the international businesses, were subsequently reconfigured and many new Units (subsets of Divisions) have since been established in the front-office Divisions of Coverage, Transacting and Project Preparations to cater for changed business requirements. Limited evaluation of the middle and back-offices was undertaken, and it is the aforementioned as well that this ToR wishes to change. In summary, both the Board as well as the Executive Committee wish to review the current operating model, structures, processes and people in order to improve on efficiencies and effectiveness for execution. The demand statement of both groups include (1) governance: improvements in accountability/responsibility and overall delegation of authority and associated processes, (2) business processes: reduction of bureaucracy and improvement in agility and resultant speed of execution and/or customer care/feedback etc. Above summary is not exhaustive, but only serves to provide an indication of that which must be addressed by the ISP. Lastly, please note that the espoused technology challenges are being taken care of in the digitalization programme, that has also been initiated and is excluded from this ToR.

With above being a high-level overview of the problem statement, the requirements listed below are for guidance on the project’s scope and are not exhaustive. Secondly, it is envisaged that the assignment will be completed over two phases, as follows:

PHASE 1

4.1. Operating Model

- a) Review and document the current operating model and organizational structures (AS IS) and craft Fit-For-Purpose alternatives (TO BE) that will cater for the DBSA's medium- to long-term strategies and execution requirements. A minimum of two alternatives must be provided.
- b) In assessing the AS IS, determine, document and provide motivation/rationale for the requisite changes/improvements, indicating all requirements (e.g. process and timelines). Determine, document and consult on the associated risks of adoption versus non-adoption for both the strategy, the effective and efficient management of the DBSA, short to medium term. Thereto and in the assessment process, consider the following in respect of deliverables and process:
 - The use of appropriate design criteria/principles, methodologies and benchmarks
Benchmarks should include national and international Development Finance Institutions (DFI's), commercial banks, Infrastructure Consulting / Development / Financing organizations and related State-Owned Enterprises. Benchmarks should also indicate if the comparators, especially DFI's are self-sustaining or state-funded/subsidized.
 - Engaging key stakeholders to obtain information, contributions and decisions (e.g. Board, Executive Committee, Management etc.) & facilitating meetings and workshops with the key stakeholders on the assessment outcomes at every stage to validate the gathered intelligence, get decisions and progress the project.
- c) Lastly, the advantages and disadvantages of each of the delivery/operating model options must be informed (researched and substantiated) before consultations with the Chief Executive Officer, Executive Committee and the relevant Board subcommittees.

4.2. Organizational Structure & Capacity Requirements

- a) Revise and propose the appropriate shape of the organization and work Units that will make up the organisation to support the agreed operating model.
- b) Recommend an appropriate organizational structure/s, starting off with the superstructure, which has the requisite levels of work and job roles included.
- c) Upon agreement of the superstructure, recommend the detailed organisational structure from N-1 to the lowest level.
- d) Establish and validate the number of job roles and headcount required for the agreed structure. The recommendation must be backed by analysis and appropriate ratios.
- e) Recommend reporting relationships, span of control, managerial added value, relationships in job size and job shape.
- f) Establish the financial and other impacts of recommended operating model and organisational structure including the potential cost implications.
- g) Workshop the above with the relevant stakeholders.

4.3. Dual Career Path Model

- a) Design a Dual Career Path Model including career progression requirements per job family in line with agreed structure of the organisation.

4.4. Job Descriptions, Job Evaluations & Job Grading

- a) Prepare job profiles for all job roles required: (a) clearly defined job accountabilities as well as technical and behavioural competencies.
- b) Conduct job evaluation and job grading for all job roles in the structure upon approval of the job profiles. The current grading system is Hay. DBSA is open to utilising the Paterson Grading System.
- c) Recommend where job roles may be utilized across Units or Divisions for maximum capacity and skills usage.

4.5. Project, Stakeholder, Change Management & Implementation Plans

- a) The bidder must provide a high-level project, change management, stakeholder engagement and implementation plans for this assignment in the tender submission as requested in the technical proposal below. The successful bidder will be required to provide a comprehensive project, change management and stakeholder plans for approval post initial consultations with the relevant stakeholders and assessment of the assignment.
- b) Prepare recommendations, submissions, presentations for the required stakeholder engagement and approvals.
- c) Provide appropriate implementation plan, change management plan and the staff engagement plan.

PHASE 2

4.6. Human Capital Strategy & Salary Survey

- a) Develop and recommend an appropriate Human Capital/People Strategy & Framework for the DBSA in response to DBSA's growth strategy.
- b) Conduct a bespoke salary survey to inform the appropriate pay ranges per job / grade taking into consideration the size of the DBSA, National Market and the SoE entities.

4.7. Close-out Report

- a) Prepare and deliver a comprehensive close-out report detailing the full project milestones delivered as agreed upon.
- b) Confirmation of the project's closure.
- c) Lessons learnt.
- d) Signatures of the ISP and the DBSA to confirm acceptance that the project has been delivered as per the agreed contract.

5. EXPECTED OUTCOMES & DELIVERY OF THE OPERATING MODEL & STRUCTURE REVIEW

5.1. The expected outcomes of the review must lead to:

- a) A Best-Fit Operating Model & Structure that will deliver on the DBSA mandate and strategy, now and into the future.
- b) A DBSA that proactively enables the organization to respond to the Shareholder, clients and market needs in a focused and value-adding approach.

- c) A clear delivery model with focused work Units, day-to-day workflows and modes of working, and the requisite levels of work, with clear roles, accountabilities, distribution of responsibilities and authority.
- d) An integrated DBSA whereby the activities are seamlessly performed between Divisions, Units and employees resulting in a collaborative approach in executing the strategy and goals.
- e) Greater economies of scale and cost efficiencies.
- f) Optimal resource allocation and deployment.
- g) Enhanced business performance.
- h) Engaged stakeholders.
- i) Improved coordination and decision making that leads to enhanced effectiveness of the organization.
- j) The ability to grow and scale quickly in response to a rapidly changing environment and circumstances.
- k) Improved risk management.

5.2. The key deliverables required of the ISP:

- a) Project, Stakeholder, Change Management and Implementation Plans approved by the core executives (part of the Steering Committee to be established, made up of the Chief Finance Officer (CFO), Group Executive : Human Capital and one/two others).
- b) An approved/revised operating model, organizational structure and capacity requirements; ***Duly consulted with the Executive Committee, submitted by the Chief Executive Officer to the Human Resources Committee and approved by the Board.***
- c) Dual Career Pathing Model including career progression for all job families; ***Duly consulted with the Executive Committee, submitted by the Chief Executive Officer to the Human Resources Committee.***
- d) Job profiles/descriptions for all jobs in the approved organisational structure (currently, DBSA has 250 jobs – all jobs have been profiled and may require tweaking/alignment by the ISP); ***Duly consulted with the Executive Committee, submitted by the Chief Executive Officer to the Human Resources Committee.***
- e) Job evaluation and grading of all jobs; ***Duly consulted with the Executive Committee, submitted by the Chief Executive Officer to the Human Resources Committee.***
- f) Bespoke salary survey; ***Duly consulted with the Executive Committee, submitted by the Chief Executive Officer to the Human Resources Committee.***
- g) Human Capital/People Strategy aligned to the DBSA growth strategy; ***Duly consulted with the Executive Committee, submitted by the Chief Executive Officer to the Human Resources Committee.***

6. TECHNICAL PROPOSAL & EVALUATION CRITERIA

6.1. Technical Proposal

Each respondent is required to submit a proposal containing the following information:

- a) A detailed response to the scope of work as indicated under the expected deliverables, including a write up on the proposed bespoke approach and methodology/ies that will be followed.
- b) Provide a project plan indicating the deliverables, and estimated time required for completion and delivery.
- c) Provide three (3) contactable references of similar assignments conducted by the ISP for similar sized or larger organisations specifically Development Finance Institutions (DFI's), commercial banks, Infrastructure Consulting / Development / Financing organizations and related State-Owned Enterprises; Specifying the exact nature of the support provided and outcomes thereof (references on client's letterhead). References must be signed by the client and the work done must not be older than 6 years.
- d) Provide the number of resources to be deployed to this project. Credentials of individuals that will be working on the project and capacity to facilitate this scope of work (Resumes of the project lead and all the resources that will work for the duration of this project).
- e) Failure to submit these documents will invalidate the bid.

6.2. Requirements & Specifications for the Project

The ISP must have the following expertise:

- a) The ISP must be in existence for at least 10 years and have a minimum of ten (10) years organisational design and stratification experience with similar sized or larger organisations.
- b) Proven track record in reviewing, aligning and developing best-fit operating models and organizational structures specifically for similar sized or larger organisations, specifically Development Finance Institutions (DFI's), commercial banks, Infrastructure Consulting / Development / Financing organizations and related State-Owned Enterprises. These must be evidenced in the three contactable references letters (see 6.1 c. above).
- c) Demonstrated ability to develop comprehensive project, stakeholder, change and implementation plans.
- d) Proven ability to prepare appropriate job profiles and conduct job evaluations using a recognized job evaluation methodology.
- e) Demonstrated ability to develop the Human Capital Strategy aligned to the strategy of the organisation.
- f) Proven track record to lead such a project to completion, engage and deal successfully with high level stakeholders of Management, Executives, the Board and Board Sub-Committees. These must be evidenced in the resumes of the project lead and all the resources that will work for duration of this project (see 6.2 d. above).

6.3. Compulsory Briefing Session

A COMPULSORY BRIEFING SESSION WILL BE CONVENED WITH ALL PROSPECTIVE BIDDERS ON THE ON-LINE MICROSOFT TEAMS PLATFORM.

6.4. Evaluation Criteria

- a) Only those Bidders who score a minimum of 80% for each of the 3 evaluation categories during the functional evaluation will be evaluated during the second stage of the Bid.
- b) Bidders are required to submit supporting documentation evidencing their compliance with each requirement, where applicable.
