The **Tender document** issued to you via the e-mail by the DBSA on the **27<sup>th</sup> of March 2024** has the following amendments.

The tender document issued included the following information. This Addendum 01 therefore provides corrected information that replaces and supersedes that as initially provided in the tender document.

#### **26.1.1.**

The score will be calculated out of 100. All bidders who achieve the minimum score of 80% will be ranked, with the top-ranking five (5) bidders prequalified. If only five (5) or less bidders achieve the minimum score of 80%, then all those bidders will be prequalified. For clarity, it is not necessarily the case that all bidders who achieve the minimum score of 80% will automatically be prequalified. Rather, it is only the bidders that achieve the minimum score **and** are ranked in top five (5) that will be prequalified. Bidders that score the same score will be allocated the same rank to ensure fairness in the ranking process.
