4. Tender Page 12 of 51, The Additional Conditions of this Eoi

- a.** Amended in line with the Tender Title amendment.
- b.** The information as per the published tender is superseded and replaced by the following:
 - i.** The process aims to generate a shortlist list of Original Equipment Manufacturers (OEM's), or its Authorised/ Accredited Distributor, of Containerized PSA Oxygen Plants, to invited bids from for future use.
 - ii.** Entities that are OEM's, or its Authorised/ Accredited Distributor, and meet the product specification and standards requirements, will be shortlisted for invitation via RFP for the design, manufacture, delivery and installation for Pressurised Swing Adsorption (PSA) Oxygen Plants in several hospitals across the country.
 - iii.** Only OEM's, or its Authorised/ Accredited Distributor as a separate entity, may tender and may not create a JV with each other or with other entities (subcontracting with other firms where relevant is allowed, in ensuring all EOI requirements are met, but they may not form part of the tendering entity).
 - iv.** To be shortlisted, tenderers must meet all stipulated criteria as defined in the EOI.
 - v.** The DBSA reserves the right to decrease or increase the required quantum of PSA Equipment sets as stipulated in the EOI.
 - vi.** Where an international OEM's local Authorised/ Accredited Distributor submits a tender, it specifically must be SAHPRA registered – in line with the Stage 1, Responsiveness criteria.
 - vii.** Where an international OEM's local Authorised/ Accredited Distributor submits a tender, the Tenderer will be required to evidence that the OEM, as the manufacturer of the PSA Plant, aligns to the strict ISO standards as defined in the Eoi – in line with the Stage 1, Responsiveness criteria.
 - viii.** Where an international OEM's local Authorised/ Accredited Distributor submits a tender, the Tenderer will be required to evidence that the Authorised Distributor relationship has been in effect for at least 12 months before tender closure.
 - ix.** Irrespective of who the tendering entity is, the DBSA reserves the right to action the same Risk Analysis and Other Objective Criteria assessments, on both the tenderer and its subcontractor/s or similar.
 - x.** Tenderers may provide information from either itself only, or based on a combination of information of its subcontractors and itself, to support and evidence the required criteria stipulated in the Eoi.
