The only available drawings relate to the North and West Works, but none have been provided for the East Works, which is the specific scope of RFP 046/2025.</p>	<p>Specification document and Single Line Diagrams provided</p>
2	<p>Inconsistent Documentation and Confusing BOQ Headings:</p> <p>Many of the documents uploaded under the East Works folder refer instead to the North and West Works. Furthermore, the BOQ document headings continuously reference North and West Works, even though the tender scope is clearly for the East Works. This creates significant confusion in pricing and technical assessments.</p>	<p>This item was corrected</p>
