TERMS OF REFERENCE (TOR)

Purpose

1. Appointment of a service provider/consultant to develop and update DBSA SCM Documents in line with new digitalized SCM process within a period of three (3) months.
 - 1.1. Develop a new and comprehensive **Supply Chain Management Procedure Manual** that documents the full SCM lifecycle, including the integration of the e-procurement process. The manual must clearly outline all relevant compliance requirements in alignment with the applicable SCM legislative and regulatory framework.
 - 1.2. Reviewing and updating new tender documents in line with SCM Legal Framework for the following:
 - 1.2.1. Non- Construction-related
 - 1.2.1.1. **Request for Proposal (RFP) template** and associated annexures.
 - 1.2.1.2. **Request for Quotation (RFQ) template** and associated annexures

Background

2. The Development Bank of Southern Africa (DBSA) is currently engaged in a comprehensive process updating its SCM System. The process includes digitalization of SCM process and updating SCM Policies and templates. The purpose is to improve operational efficiency and compliance with relevant regulations such as the Public Finance Management Act (PFMA), the Preferential Procurement Policy Framework Act (PPPFA) and its associated regulations, the Construction Industry Development Board Act (CIDB) and its associated regulations, as well as various instruction notes applicable to Schedule 2 entities as issued by the National Treasury.
3. The DBSA SCM Unit currently operates under multiple governance documents and manual processes. However, there is a requirement for a service provider to document the newly envisioned SCM system and processes, in its SCM Procedural Manual as well as develop updated tender documents that comply with relevant legislation and regulations. DBSA is in the process of implementing an e-procurement system, updating its SCM policy, and revising certain templates. DBSA has embarked on digitalization strategy, and part of the strategy include the digitalization of SCM System and its processes. While ensuring that all processes are aligned to SCM Legal Framework.

Scope of Work

4. The proposed review of the Supply Chain Management (SCM) governance documents encompasses the following key elements:
 - 4.1. Review DBSA SCM legal framework.
 - 4.2. Review the e-procurement system and its documents for purposes of documenting new SCM process in Supply Chain Management Procedure Manual.
 - 4.3. Develop a comprehensive Supply Chain Management (SCM) Procedure Manual that covers the entire SCM cycle, incorporating the new e-procurement process. The manual should integrate the following: the previous procedural manual, the current "as-is" processes, and the newly implemented procurement process, combining them into a single, cohesive document. The selected supplier must be able to align with all three processes seamlessly.
 - 4.4. Outline the key stages of the supply chain, from initial planning through to the final product delivery. Describe how each stage is interconnected and explain the relationships and dependencies between them to provide a clear understanding of the overall process.
 - 4.5. Attend SCM e-procurement workshop to gather system overview.
 - 4.6. Prepared to engage the e-procurement service provider directly to reach the project objective.
 - 4.7. Reviewing and developing new tender documents in line with SCM Legal Framework for the following:
 - 4.7.1. Non- Construction-related
 - 4.7.1.1. **Request for Proposal (RFP) template** and associated annexures.
 - 4.7.1.2. **Request for Quotation (RFQ) template** and associated annexures
 - 4.8. Conduct at least two workshops to get buy-in and feedback on Draft documents.
 - 4.9. Train SCM Officials on the compilation of RFQ and RFP documents
 - 4.10. Have one on one meeting with some SCM officials for purposes of documenting as-is process.
5. The bidder must ensure that these documents are meticulously drafted, reviewed, and updated in accordance with the requirements outlined, with attention to detail and compliance with relevant regulations and guidelines.
6. The appointed bidder will be expected to have access to copy-editing services for reviewing of grammar, spelling, punctuation, and syntax errors etc.
