4. Additional Tender Condition

- a) The per kilometer rate for the reimbursement of travel expenses shall be limited to the kilometre rates published by the Department of Public Works from time to time for vehicles with engine capacities of various capacities but not exceeding the maximum of 2500cc for the purpose of this contract. If 4x4 vehicles or other vehicles exceeding 2500cc are required due to accessibility or poor road conditions, the applicable rate needs to be agreed between the Service Provider and the Employer upfront before trips are undertaken. The prices tendered in Schedule C2.2.3. should be on the basis of a vehicle with 2500cc engine capacity. Please note that the first **100Km** (roundtrip) of every travel should not be claimed for by the Services Provider, it should be part of the cost in the Professional fees. The base travel will be calculated from the nearest of DBSA or the PSP office.
